2016 Ranking: 19th Largest Export Market for U.S. Goods. (2015: 19th)


With growth in exports between the two countries, Saudi Arabia is the second largest export destination in the Middle East for the United States. Consistent with global trends, U.S. goods exports decreased by 8.47 percent in 2016, reaching \$18.02 billion, while Saudi exports to the United States decreased by 23.34 percent in the same year. Among the top imported sectors are Transportation Equipment, Machinery (except Electrical), and Chemicals.
