"Cross-cultural understanding, nurtured by organizations like NUSACC and the Shafik Gabr Foundation, plays a vital role in the relationship between the United States and the Arab world," Hamod noted. "NUSACC supports people-to-people programs like this one because, at the end of the day, they are essential to building professional capacity and strengthening commercial partnerships."

Ambassador (ret.) Gordon Gray, NUSACC's Executive Vice President, reflected on his three years in Cairo as the Deputy Chief of Mission at the U.S. Embassy and discussed opportunities for expanding U.S.-Egyptian trade, as well as some of the current challenges standing in the way of greater commercial interaction. He noted that Egypt is the third largest market in the Arab world for U.S. goods exports, and that the United States is Egypt's largest trading partner.
